Eye Contact: If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Skin Contact: If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call poison control center or doctor for treatment advice.

6. ACCIDENTAL RELEASE MEASURES

Emergency Action

Isolate spill or leak area immediately. Keep unauthorized personnel away. Stay upwind. Keep out of low areas. Ventilate closed spaces before entering.

Do not touch or walk through spilled material. Wear appropriate personal protective equipment during cleanup.

Small Spills: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Prevent material from entering sewers, waterways or low areas.
