A concentrated cleaner for animal accommodation and watering systems in sheds, barns, stables or sties.

**DIRECTIONS FOR USE:**

1. Dilute BioSentry® DSC 1000™ 1 part to 1000 parts of water (1:1000) and then spray over interior surfaces (applying about 300 mL/m<sup>2</sup>), at low pressure, after the shed, barn, stable or sty has been emptied and litter/bedding has been removed.
2. Allow to stand for 20 to 30 minutes and then proceed with normal wash out procedure.
3. Feeders, drinkers, cages, crates, utensils and vehicles can be sanitized using the 1:1000 working solution.
4. To cleanse watering systems, first empty the system, refill with the 1:1000 solution, leave overnight, then flush thoroughly with water from natural source.

**GENERAL INSTRUCTIONS**

**MIXING:** Measure the amount of concentrate required to make up the desired volume of working solution. Dilute the measured amount with twice its own volume of water and stir thoroughly. Then add water to about half the desired volume of working solution. Stir thoroughly again and then make up to final volume, stirring continuously. The working solution of product diluted to 1:1000 in water is non-irritating, non-staining and of low toxicity. Sheds, stables, etc., sanitized with this product require disinfection before restocking.

**PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND THE ENVIRONMENT:** DO NOT contaminate any pools, dams, streams or other natural water systems with any rinsate from sprayed areas, unused spray mix, used containers or product.

**STORAGE AND DISPOSAL:** Store in a cool, dry place below 30°C (room temperature). Keep lid firmly closed. Triple or, preferably, pressure rinse containers before disposal and add rinsate to spray tank. DO NOT dispose of undiluted chemical on site. Destroy empty containers by breaking, crushing or puncturing them. Dispose of container in an authorised landfill where rubbish is buried at least 500mm below the surface and not burned. If not available, bury containers below 500mm in a disposal pit specifically marked and set up for this purpose, clear of waterways, vegetation and roots. DO NOT burn empty containers or product. If there is excess spray mix to dispose of, it is best sprayed lightly over the entire surface already treated and should not be held for further use.

**SAFETY DIRECTIONS:** The undiluted product will irritate the eyes, nose, throat and skin. Do not inhale spray mist. To prepare working solution wear cotton overalls buttoned to the neck and wrists (or equivalent clothing) and elbow length PVC gloves. Wash hands after use. After day's use wash gloves and contaminated clothing.

**FIRST AID INSTRUCTIONS:** If poisoning occurs, contact a Doctor or Poisons Information Centre (phone 1-651-5230318, collect calls will be accepted). If swallowed DO NOT induce vomiting. Give a glass of water. If skin contact occurs, remove contaminated clothing and wash affected area thoroughly with soap and water. If in eyes, hold eyes open, flood with water for 15 minutes and see a Doctor. Further information is contained in the material safety data sheet.
